Introductions.

Harry Hill Update

- The legislative session ended yesterday at 6:00 p.m.
- State pay raises scheduled to be implemented 6 months after the beginning of the fiscal year. Delay due to rising health care costs.
- Lots of questions about the paycheck protection act, who will be exempted, fire fighters, police. Continue to lobby for MoDOT employees to be exempted under first responders.
- Paycheck protection will go into effect August 28, 2018 unless specific lingual is included.
- Need to discuss HB 1413 (paycheck protection) and TEAM's strategy with Patrick McKenna.
- TEAM is not the target of this bill.
- There are a lot of unanswered questions about this bill. Harry will know more in a week or so.
- SB 617 which would add a 10¢ per gallon phase-in died before passing as did the motor vehicle fee increase to keep up with inflation.
- HB 2092 would go to a public vote to increase gas tax by 10¢ and diesel by 12¢ failed in special rules committee as did the 14 day pay period bill.

Statewide Financial Report/Information

- Dave Taylor provided the statewide financial information.
- Motion for Dave Taylor to do chapter dues by auto transfer into the chapter credit union. Requests board member send him an email with the routing numbers and contact name. Motion passed.
- Statewide President Dave Sims emailed Keith Long from the Northeast Chapter re meeting but received no response.



- Discussion re the paycheck protection act (HB 1413). TEAM needs to be exempted if at all
 possible or TEAM will have a lot of difficulty surviving.
- Discussion about the Active and Retired Missouri State Employee Association. Who is their lobbyist? Recent bi-laws change to allow active employee membership. Like TEAM, they are legislative driven.
